- Successful completion of year 12 or equivalent or acceptable English language, literacy and numeracy skills
- Unique Student Identifier (USI)
- Must be an existing worker in the community services industry

Qualification

This qualification reflects the role of workers participating in the design, implementation and evaluation of leisure and health activities and programs for clients in one or more sector areas.

Worker may be in residential facilities and/or in community agencies and day centers, completing specialised tasks and functions in relation to leisure and health. While workers are responsible for their own outputs, work is carried out under direct or indirect supervision within defined organisation guidelines.

Pathways to further study

This course covers units from the national training package, so participants may receive recognition towards other qualifications including Certificate IV in Ageing Support, Certificate IV in Disability, Certificate IV in Mental Health or Diploma of Leisure and Health (Diversional Therapy).
